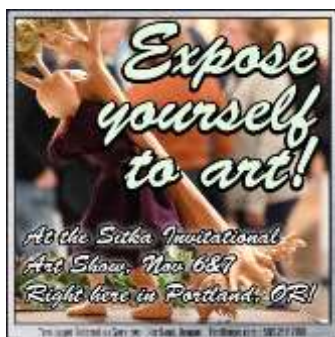

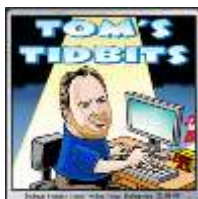

## Is Facebook the future of corporate responsibility?

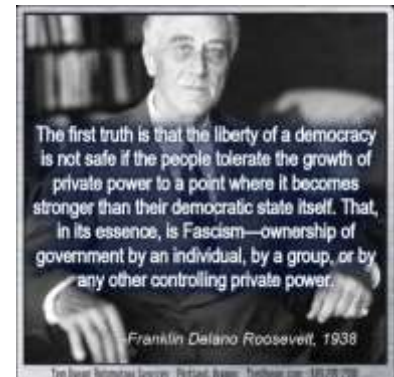
Do you remember Frances Haugen? She, and her allegations are already fading away, but she was the insider who gave us evidence Facebook consciously prioritized profit over teen suicide.

In some ways she didn't tell us anything new. Instead, she did something even more important these days... she confirmed what we all suspected. 'Everyone' has 'known' that Facebook is a damaging juggernaut that needs to be reined in, but we all make too many conclusions without enough facts. Haugen told us all we were right, and laid out why. And now I'm not sure what should be... or even could be... done about it.

Facebook joins a long line of corporations trading dollars for lives. We were all pretty darn sure cigarettes were linked to cancer well before [the tobacco companies' knowledge](#) came to light. Scientists (and as a result, rational people) have long thought Big Oil understood the scientific link between fossil fuels and Climate Change, so it wasn't a surprise to find [they've been cynically lying about it for decades](#). Pretty much every suspected the Health Insurance companies were/are colluding to prevent Single Payer, the lack of which kills [260,000 Americans](#) every year. It took [Wendell Potter blowing the whistle](#) from the inside to make it undeniable.

If Facebook is a problem, it's only one facet of the whole problematic Internet. In the heady days of the 80's the Net promised nothing but good, and social media was just one more benefit. After all, what could be wrong with knowing more about Aunt Edna's alternative health remedies or Uncle Ernie's insights on politics? As the Net has grown we've found the ugly dark side. As with the internal combustion engine and atomic energy, no one understood the downsides for years or decades after the technologies were created. Once the downsides were understood, the need for regulation became apparent. Facebook and the rest of the Net might not have needed regulation when they started but they do now, and now they've helped neutered the government implemented to do it.

Constitutional government, at least in America, is explicitly intended to secure the rights of life, liberty, and happiness for the governed, from threats both foreign and domestic. That doesn't just mean governing people, but also companies and other entities. (Even more so since the fine folks at the SCOTUS told us [corporations were people too](#).) Yet the government, OUR government, seems powerless to intervene. Why? Well, [Facebook spent \\$19.6 MILLION](#), by itself, on lobbying in 2020. They were hardly alone, with just the five Big Tech companies combining for \$61.09 million ([outstripping defense and telecom](#)). And now, shockingly, Congress just can't find the stomach to intervene in Big Tech. Faced with that spigot of cash, it's tragically unsurprising they see teen girls and the many other casualties of the Internet as disposable.



Tom Dwyer Automotive Services is hardly Facebook, but I can't help drawing parallels to my own company. I can't imagine a situation where I knew our company was endangering our clients yet *chose* to not to act! We know auto travel as a whole is dangerous already, so we take our role incredibly seriously and [design our policies and procedures to make sure our clients are as safe as they can be](#). On the rare, rare occasion there's a violation the people responsible are held accountable. As politically vocal as our shop is, we don't spend a dime trying to lobby for looser restrictions, lower wages, or lower taxes. Instead, we advocate for sensible restrictions when needed, living wages, and appropriate taxes, especially on wealth. I think there is a proper role for companies in politics, and for politics in companies, but Facebook's example isn't it. Our shop is politically active, but even the people who think they know 'my politics' are wrong. I'm neither a Republican nor a Democrat; I don't play 'team' politics at all, and I (or my company) might come down on any side of any particular issue. The proper role is a delicate balance, and we're running our "Business Or Politics?" article this month to talk about it in greater depth. We put a lot of thought and consideration into it and I hope you take a few minutes to read it.

As a company changes from a sole-proprietorship to a small corporation to a global behemoth, the personal responsibility and obligations of the owners change as well. Yet I think some standards should apply no matter the size, and the safety of the customers seems non-negotiable. While most of the public would [agree with me on this](#), but the handful of corporations who have bought our government think otherwise. As long as America operates on the Golden Rule instead of the Constitution then the situation will continue, because 'he with the gold makes the rules'. Don't know about you, but it's not the way I think things should be run.

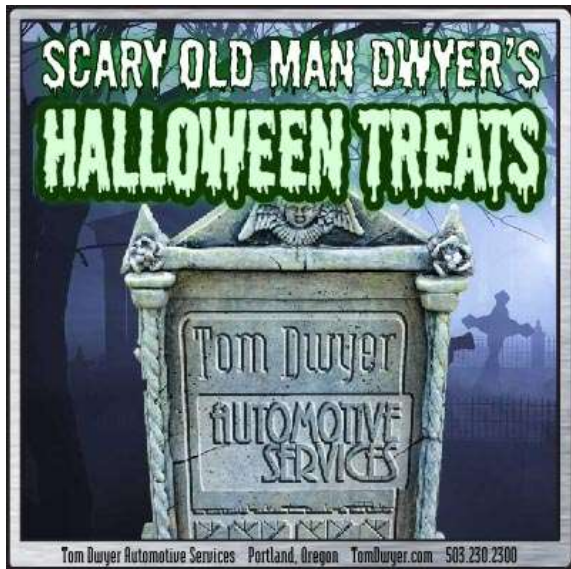

They delivered the mannequins in bubble wrap. From the main room I begin to hear popping.

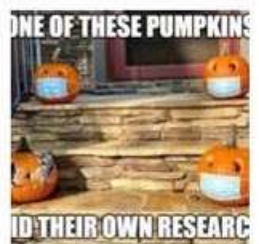
I kiss my wife and daughter goodnight before I go to sleep. When I wake up, I'm in a padded room and the nurses tell me it was just a dream.

## **Business or Politics?**

People ask! Here's why we loudly say "YES" to both

It's common wisdom for a company to stay far away from politics, but we certainly don't. Three years ago on [Quora.com](https://www.quora.com) (a Q&A forum we follow and highly recommend) someone posed the question "[I work in financial services. Can I legally refuse service to Democrats?](#)" We took the opportunity to reply with the motivations for our own political outspokenness, and our response may have grown more relevant since. If you've wondered why we talk about politicians and voting almost as much as tires and brakes, we hope this might give you some insight...

### **Should Business and Politics Mix?**

When a client recently asked about our "#NotNormal-RESIST!" bumper stickers, we told her they "were in protest of the new administrations irregular behavior". It didn't sit well. "Politics has no place in your business", she said. "I'm never coming back here again, and I'm telling my friends to do the same". Maybe she was right... keeping politics out of business is basic business advice; after all, why give any person any reason NOT to come to your business? Profit is critical in business but some things are just as important as profit. Staying quiet about those higher priorities can border on criminal, especially in today's world or to protect a dollar. Here's Tom to explain why he puts his company's neck on the political chopping block time and again, and why he's not likely to stop...

Greetings,

Here's a little secret... I was a registered Republican for 20 years before my political awakening. When I started my business 36 years ago I was politically clueless... I didn't even know the difference between the major parties! After a cursory investigation it seemed [Republicans were the party of business](#) and a little business networking seemed to make sense. It was a different time then. I never changed my registration because I was politically inert and was too busy trying to survive in business to care about politics, but around 1998 a co-worker helped direct my available bandwidth to some sources of real news and reporting. That set me on a path to enlightenment and the understanding that my interests would be best served if I woke up.

Reagan understood that people that are ill-educated, poor and over-worked seldom cause political ripples. He famously stated the reason he opposed free education: "why would I want to pay to educate people who would oppose my policies?" The decline in availability and quality of free public education, the "dumbing down of America" brings with it many slow insidious side effects and has led to the decline of Democracy. Civics and History are critical tools in the fight for political self-determination, but it seems we are no longer citizens and have become just people-that-live-in-America. "Citizens" should not be just passive residents in a society; the role of "citizen" obligates us to participate in creating the society we want.



I'm not a Republican OR a Democrat and I think my beliefs are widely shared by the people of (if not the leadership of) both parties. Both of the major parties have lost their way. The two party system is broken; The Republican leaders have fallen off the right side of the political landscape and the Democrats are no longer the opposition party. They have become Republican-lite and with very few exceptions mirror the Republicans subservience to the Corporate donors that now rule our failing country.

[We are no longer “#1!, #1!, #1!” unless you are referring to poverty, hunger, infant mortality, bloated military, crumbling infrastructure or any of the other sad realities that we now lead in.](#) I believe that government should work for the poor, the middle class, and the wealthy alike. I want a society that cares for its members and protects the commons, and I believe in the basic principles of accountability, freedom, and rule of law that people have died for for more than two centuries. I believe that corporations should not have the rights of people and that they have far too much control over our society. I think we do better as a country when everyone plays by the same rules.

With all the years I've put into Tom Dwyer Automotive Services it would have been impossible to keep my views out of the office even if I tried. For example, like every business we're asked to sponsor many worthy causes. We obviously can't support them all, so I choose what I think are important issues like [single-payer health care](#) or [climate change](#). You'd get bored if our [newsletter](#) was about cars month after month so we try to bring you information on topics like [police militarization](#) or the [federal budget](#). When our company chose to advertise [we picked a fledgling Progressive station](#) as an alternative to the Rush Limbaughs of the world, and instead of driving clients away the response was very positive.

Business has always been tied to politics... the titles “Merchant Prince” and “Robber Baron” have a long history. The [British East India Company](#) played quite a role in our country's earliest days, and “What's good for GM” was once assumed to be good for the country. [Standard Oil at home](#), [United Fruit in Central America](#), and [Halliburton in the Middle East](#) are three notorious names in global politics. [Fossil fuel companies lobby for laws](#) to continue profits even as the planet melts down while [ALEC now puts lobbyists in the position of actually writing bills](#). The closely held [religious views of Hobby Lobby and Chick-fil-A influenced recent decisions](#) at the Supreme Court. BIG businesses have never shied away from politics even when they were being quiet about it, but for SMALL business silence has always been the rule.

That's been changing for a while. [Local Chambers of Commerce](#) never go beyond local politics and the [NFIB seems to use small business as a fig leaf](#) to advance big business agendas, but the evisceration of Main Street and the Middle Class have forced small businesses into politics for self-defense, if nothing else. Groups like the [Main Street Alliance](#) and [National Small Business Association](#) give small companies a way to bind together on issues bigger than their own industry or business district. Increasingly, small businesses aren't waiting to bind together but are taking stands on their own. Individual small business voiced concerns throughout the Obama administration, and Trump's recent [travel ban prompted thousands of small businesses to close in protest](#). More and more businesses are putting up signs, or making donations, or hosting events that resonate with their own ideas of politics.

And customers seem to like it. The sterile, bland, and impersonal service at large companies comes from searching for a common denominator between ever-larger swaths of the population. Smaller companies serve their smaller niches more responsively, and so have more room to add distinct personality to their businesses. This gives their customer an advantage. Rather than patronizing some Big Gray Company with an obscure agenda the customer may not agree with, they know what the company stands for and can choose to support them... or not. Politics in business is a two-way street; a company can speak out but they'll have to stand by it when their customers vote with their dollars.

I think politics does play a role in business but not a primary one. I don't push or preach politics and many clients don't even notice or care, and that's as it should be. No company should offer products, services, or employment based on a political stance. Our shop isn't a political indoctrination facility for our employees

or our clients; we don't hire people based on their t-shirts or decide which cars to service based on their bumper stickers. If Rush Limbaugh lived in Portland we'd proudly give his vehicle the same care and attention we gave Thom Hartmann when he lived here.

Yes, politics is important and I don't shy away from it, but I run a business. I will never forget that our most important goal is our core mission statement: To deliver our clients impeccable, professional service beyond the rest of the industry while taking the best possible care of the people that make Tom Dwyer Automotive Services possible. I started working for myself in 1981 after my last-ever employer asked me to perform unnecessary work on a customer's vehicle. After pushing back unsuccessfully the wheels on my tool box went into action and I've never looked back.

## **When to part with your car**

### How to know when it's time for the Automotive Graveyard

We answered another question on Quora.com this month, and thought many of our clients may be interested as well. Emirey J. asked [“Is there any rule of thumb to decide whether to repair an old car or get a new car?”](#) This is one of the most common questions we hear, and as we told her, there's no right or wrong answer. It all depends on your plans for the vehicle, your budget, and the repairs on the horizon. There's no simple answer, but there are

hints...

There are two broad options for sensible vehicle ownership: either keep it maintained and drive it until the wheels fall off, or do minimal maintenance and trade in for a newer vehicle every few years. Both have pros and cons, but “when is it time to give up?” is one of the most difficult questions we solve with our clients because each person's expectations for their vehicles are so different. There's no single right-or-wrong answer, but you should be aware in talking with your mechanic that they often approach the question a little differently than you would.

Vehicles (much like humans) tend to gobble up the most repair money in the last months of their lives as system after system reaches the end of its planned design life. When Tom started as a mechanic in the seventies he was told ‘no vehicle is ever beyond repair’, which is true from a shop's viewpoint. Virtually all auto repair shops these days are commission-based and they often see older vehicles as cash cows. The longer they can be kept limping along, the longer the owners will pump money into the shop coffers. This is rarely in the vehicle owners' interest, so in most cases you'll be the best judge of when the plug needs to be pulled. Be wary.

Chances are you have a repair estimate that prompted the “should I give up” question, but that's probably not all the repairs you face. Start by finding a qualified mechanic or shop you trust to go over the ENTIRE vehicle and tell you what's likely to fail soon. We offer an in-depth Comprehensive Inspection to do exactly that, but not all shops do. However, almost all offer a “free inspection” of some type that might find obvious problems. Get that if it's the best you can find, but tell the shop what you're looking for from the inspection and tell them to go as deep as they can. Most cities have mobile inspection companies that check out used cars for purchase; one of those could be a very helpful alternative.

Next, determine the value of your vehicle using resources like Kelly Blue Book. You'll find a price, but your vehicle's VALUE is that number MINUS the repair cost of current breakdowns, MINUS any repairs you see on the horizon. (You might not do ALL those repairs if you're planning to sell the vehicle, but you should definitely include safety-related items like brakes.)

Now you have your choices... fix it, or sell it and use the money (plus whatever money you saved on repairs) as a downpayment on a different vehicle.

By itself, a big repair bill isn't necessarily a deal-breaker. Suppose, for example, your vehicle is worth \$5000 but it will cost \$2500 to fix its dead transmission. \$2500 is a big bill by any standard, but what kind of vehicle will you have when the repairs are finished? If it's a good, solid vehicle (like a Toyota or Honda) with few other issues, then it seems wise to do the repair because you'd have a reliable vehicle afterwards. Even if the vehicle has a shorter design life (like a VW or Hyundai) but still has few other issues, it might still make sense to do the repair. But if other major systems about to fail, if that big bill is just the start of what you're facing, then it probably makes sense to move on to a different vehicle.

When should you give up on a car? The decision is totally up to you, your expectations of your vehicle, and your budget. I hope this has given you some good general advice, but if you REALLY want specifics we found [an article in Motor Magazine that offers extremely detailed math on the question](#). It's more complex than most people want, but probably very useful if you want to dig deeper. Good luck!

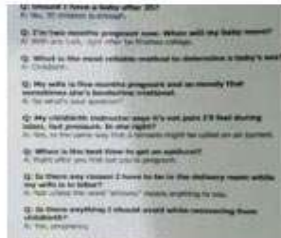
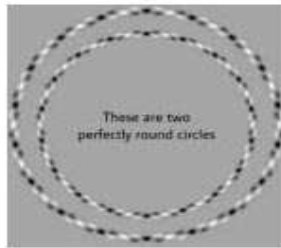

## We respond to a Bad Review



### Comment of the Month



Henry B. offered this month's Comment via Google, where he gave us a 1-star review. Our response is below, but you can always find it and all our other bad reviews at [OUR BAD REVIEWS](#).

Henry Brentlinger, Google review, 1 star out of 5-

*TOM DWYER WILL NOT WORK ON CARS THAT HAVE A BRANDED TITLE. I learned this after waiting in line for two weeks to get my started replaced. Once they received my car (not yet aware that my title is branded) they quoted me \$850 to change out my starter. This quote sounded incredibly high so I shopped around and found multiple mechanics in town who quoted \$450-\$500. On top of this they then tried to sell me on a laundry list of fixes including the classic "Your cabin air filter is dirty". When I called to have Tom Dwyer explain their pricing I mentioned that my title was salvaged in which case they explained to me that they will not even touch my car. I have never had another mechanic say this is an issue and nowhere on their site does it mention that this non-starter. After two weeks of waiting and accumulating 2 rounds of tow fees, I still have a car that will not start.*

Our Response- We hate to say it, but Henry's major point is right on target... we don't work on branded title (salvaged, reconstructed, retitled) vehicles and we should have brought it up with him when he called. We don't apologize for the policy, but we certainly apologize for Henry's bad experience because it was clearly our fault. The salvage-title policy IS on our website, but buried too deeply for anyone to see and our Webmaster should have made it much more obvious. Our Service Advisor should have asked about the vehicle's title status when Henry scheduled and referred him to a shop that could have met his needs, but he didn't. Those minor errors combined into a major waste of two weeks' time, and Henry, we apologize.

On Henry's point about pricing, we understand. But for every review we have that mentions our high prices, another mentions how much lower we were than some other shop. We may be higher or lower than any particular shop on any particular repair, but in the long run we think we offer the best balance of price and quality anywhere.

Part of that quality is the assurance you won't be up-sold, pressure-sold, or sold services you don't need, and we didn't in Henry's case. We had already checked out Henry's car and told him we weren't going to work on it, but Kyle put together an estimate for the work it needed so Henry would have it when he found a new shop. Dirty cabin air filters are 'classics' because they get dirty... that's how they work. We told him it was dirty because that's what we found when we physically examined it, and let him decide whether or not to replace it. When we start with any new client we examine their vehicle, tell them EVERY issue we found, then prioritize the repairs. It's up to the client to decide what work

to do based on their schedule and budget. Since we didn't plan to do any work at all for Henry, we certainly didn't try to 'sell him on a laundry list of fixes'.

Every business has its own restrictions, but it's on the business to tell potential clients about them and we didn't. Henry, thank you for pointing out our failure on this. Our Service Advisors have been reminded to ask about title status so the next person won't have the same inconvenience you did. More obviously, our Webmaster added a salvage-title notice to our website right up front where it belongs. We apologize again, and hope you found a shop that is more helpful than we could be. If you get a non-branded vehicle in the future, we invite you to give us a call again. We promise you a very different experience!

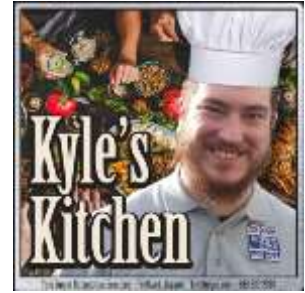

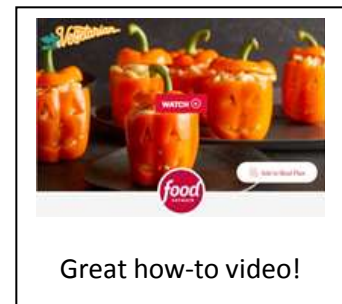
### Mac-O-Lantern and Cheese Bowls

#### Ingredients:

- Kosher salt
- 6 medium orange bell peppers
- 8 ounces elbow macaroni
- 1 1/4 cups half-and-half
- 8 ounces cream cheese, at room temperature
- 4 ounces mild Cheddar, shredded (about 1 1/2 cups)

#### Preparation:

- Bring a large pot of generously salted water to a boil. Fill a large bowl with ice water.
- Cut the tops off the peppers and reserve. Remove the seeds and membranes. Put the peppers and the tops in the boiling water and cook until just tender, 2 to 3 minutes. Plunge the peppers into the ice bath. Once cool, remove them and use a sharp knife to carve a jack-o-lantern face into one side of each pepper.
- Return the water to a boil, add the macaroni and cook until al dente, about 6 minutes. Reserve 1 cup of the pasta water and drain (don't rinse the pasta).
- Heat the half-and-half in a large saucepan over medium heat until it just comes to a simmer. Continue simmering until reduced to about 3/4 cup, about 10 minutes. Add the cream cheese and stir until melted. Whisk in the Cheddar until all the cheese is melted and the sauce is smooth.
- Off the heat, add the macaroni to the saucepan and stir to combine. Stir in some of the reserved pasta water to thin the sauce if needed. Season with salt if needed. Let sit for 10 minutes, then divide the mac and cheese among the peppers and cap each with a pepper top.

## Brain stimulation offers hope for depression

After years of suffering, a patient with severe and untreatable depression has finally found relief with an experimental brain implant originally developed to help people with epilepsy, researchers in California reported Monday.

It's only a single patient, but the team at the University of California San Francisco says it has seen remarkable results with the device, which is calibrated to detect the signals associated with depressive symptoms in the patient's brain, and interfere with them.

"When we turned this treatment on, our patient's depression symptoms dissolved and in a remarkably small time she went into remission," Dr. Katherine Scangos, a psychiatrist and neuroscience specialist at UCSF who led the study team, told reporters, "It was like a switch."

One year later the patient, who is identified only as Sarah, says the device has banished her depression with no side-effects. "I had exhausted all possible treatment options with no success at lifting the depression that had descended five years earlier," Sarah told reporters.

"My daily life had become so restricted and impoverished by depression that I felt tortured by each day and forced myself to resist the suicidal impulses that overtook me several times an hour. When I first received stimulation, I felt the most intensely joyous sensation," she added.

"And my depression was a distant nightmare for a moment."

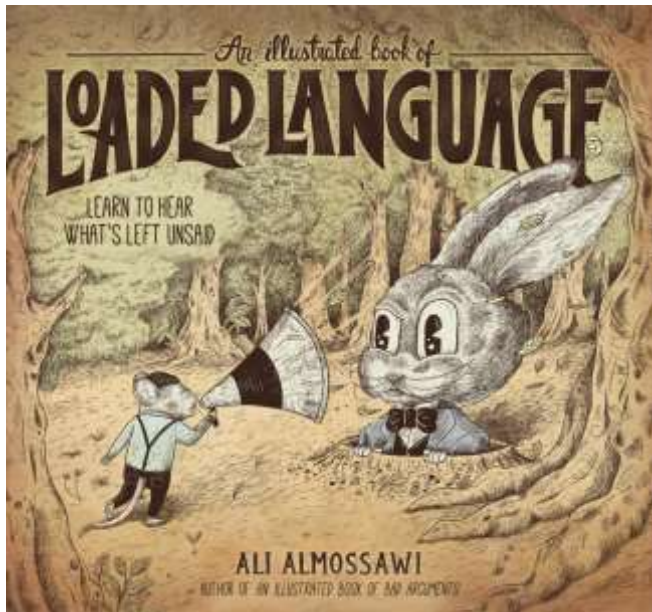
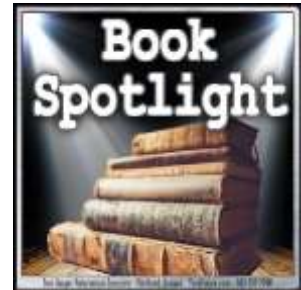

## “An Illustrated Book of Loaded Language” by Ali Almosawi and Alejandro Giraldo

Tens of thousands of demonstrators packed the city's streets on Friday. The actual count was 250,000. Why tens of thousands, then, and not a quarter million?

The grocer takes woke orders on its brands from a 17-year-old. The nameless 17-year-old's opinion seems not worth considering. At what age will it be?

Rabbits zapped three badgers in an ambush last night, hours after six rabbits in a neighboring town lost their lives. Were the six rabbits the sole participants in losing their own lives? Those silly rabbits . . .

In this adorably illustrated book, old Mr. Rabbit is your guide to these and many more examples of loaded language. He mines real reporting (by respected and rogue media alike) to unmask rhetoric that shifts blame, erases responsibility, dog-whistles, plays on fear, or rewrites history--subtly or shamelessly. It takes a long pair of ears to hear what's left unsaid--but when the very notion of truth is at stake, listening for "spin" makes all the difference. The creators of An Illustrated Book of Bad Arguments return at last with a desperately timely guide to rhetoric.

Public discourse? More like public discord. The battle cries of our culture wars are rife with “loaded language”—be it bias, slant, or spin. But listen closely, or you’ll miss what Ali Almosawi finds more frightening still: words that erase accountability, history, even identity through what they leave unsaid.

Speaking as wise old Mr. Rabbit, Almosawi leads us through a dark forest of rhetoric—aided by Orwell, Baldwin, and a squee-worthy cast of wide-eyed woodland creatures. Here, passive voice can pardon wrongdoers, statistics may be a smokescreen, gaslighting entraps the downtrodden, and irrelevant adjectives cement stereotypes. Emperor Squirrel isn’t naked; he has a clothes-free sartorial style. Mouse’s roof becomes flattened (Elephant’s foot just happens to be there at the time). And when keen-eyed Owl claims a foreign shore, he seems to be overlooking someone . . .

Yet that has not stopped them from ardently searching for an additional, as-yet-unknown fifth fundamental force. The discovery of such a force could potentially resolve some of the biggest open questions in physics today, from the nature of dark energy to the seemingly irreconcilable differences between quantum mechanics and general relativity...

### [New nuclear fusion reactor design may be a breakthrough](#), Stephen Johnson in TheBigThink, Mar 2020

The promise of nuclear fusion is tantalizing: By utilizing the same atomic process that powers our sun, we may someday be able to generate virtually unlimited amounts of clean energy. But while fusion reactors have been around since the 1950s, scientists haven’t been able to create designs that can produce energy in a sustainable manner. Standing in the way of nuclear fusion are politics, lack of funding, concerns about the power source, and potentially insurmountable technological problems, to name a few roadblocks. Today, the nuclear fusion reactors we have are stuck at the prototype stage. However, researcher Michael Zarnstorff in New Jersey may have recently made a significant breakthrough while helping his son with a science project. In a new paper, Zarnstorff, a chief scientist at the Max Planck Princeton Research Center for Plasma Physics in New Jersey, and his colleagues describe a simpler design for a stellarator, one of the most promising types of nuclear fusion reactors...

### [After decades, room temperature superconductivity achieved](#), Bobert Service on Science.org, Oct 2020

Fulfilling a decades-old quest, this week researchers report creating the first superconductor that does not have to be cooled for its electrical resistance to vanish. There’s a catch: The new room temperature superconductor only works at a pressure equivalent to about three-quarters of that at the center of Earth. But if researchers can stabilize the material at ambient pressure, dreamed-of applications of superconductivity could be within reach, such as low-loss power lines and ultrapowerful superconducting magnets that don’t need refrigeration, for MRI machines and maglev trains.

"This is a landmark," says Chris Pickard, a physicist at the University of Cambridge. But the extreme conditions of the experiment mean that even though it was "pretty spectacular," says Brian Maple, a physicist at the University of California, San Diego, "this is certainly not going to be useful in making a device."
